The undersigned Parties agree that the terms of this agreement are as follows:

A. Licensee must provide a final count of climbers no later than 2 days prior to the scheduled event time and that will be the bases upon which the minimum payment amount is determined. Any additional climbers that attend in excess of the number reported may only be accepted by Cliff Hangers management based on their sole discretion that the number of staff scheduled is sufficient for the additional participants attending the event. Additional climbers that are allowed to participate on the day of the event will pay the regular rate of \$20.00 each.

B. Payment terms are as follows: A Non-refundable Deposit of \$50.00 must be paid on the date of the event booking which must be at least 2 weeks prior to the scheduled event time. Balance of the minimum fee is to be paid 2 days prior to the event when the total count of climbers must be provided. Payment can be made by credit card or check.

C. The Licensee understands and agrees that all participants must adhere to the posted and verbal rules and policies of Cliff Hangers, LLC and failure to do so may result in the individual or group dismissal from the facility without refund.

D. A waiver must be signed for all climbers before entering the climbing area. It is highly recommended that waivers be completed online to save time with check-in.
